## **"CHALLENGES TO THE VOTE: ELECTIONS 2012 AND ELECTION LAW"**

In 2012, voters will once again face the reality of national and local elections being held with processes that have increasingly come under challenge. Though it has been twelve years since the Florida debacle, the fact remains that election services to poor and minority neighborhoods are less adequate than those that serve wealthy districts. Voting machines are being used in current elections that produced questionable results in the 2004 and 2008 elections. Laws are being introduced and passed that may restrict the ability of US citizens to register and to insure that their cast ballots will be counted. These problems will face voters at the same time that corporate contributions will be at an all-time high, with the sources of that money screened from full scrutiny.

A panel of local election specialists will examine the issues facing voters and facing organizations that will be doing their best to "get out the vote". Can we solve them all? No, but knowing what those problems are will surely better equip us to deal with them as they are encountered. Learn what the current situation is and what propositions related to voting might be on the November 2012 ballot here in Arizona.

Come and bring your friends and neighbors for a discussion on what the LWV can and will do during this election year.

## NEW LWVAZ POSITION ON THE EXECUTIVE BRANCH STUDY

All of the local Leagues did a study with consensus to update the Executive Branch position. The following is the new position that was adopted at the LWVAZ January Board meeting:

The LWVAZ believes that a clear line of succession in the Executive Branch of the State of Arizona should be more obvious to the public than it is in the current system where the Secretary of State assumes the role of Governor in times of absence, removal, resignation, death or other such changes. To avoid mid-term changes in party, continuity problems or policy reversals, the LWVAZ supports the creation of an Office of Lieutenant Governor with duties separate from that of the Secretary of State.

In addition, the LWVAZ believes that the governor and the elected office that is next in line of succession to the governor should run on the same party ticket. If that office continues to be held by the Secretary of State, the LWVAZ strongly believes that all partisan aspects of elections should be removed from the jurisdiction of the Secretary of State and managed by an independent body/commission. ## CENTENNIAL LUNCHEON TO HONOR DOÑAS

At the LWVGT February 17 luncheon, we will recognize some outstanding local women, las Doñas de los Descendientes del Presidio de Tucson. These prominent citizens have made our community a better place in so many ways.

LWVGT member Dr. Anna Jolivet has had a distinguished career as a Tucson educator, principal, and assistant superintendent of schools. In 2001 she was honored by the UA College of Education with an outstanding achievement award. She also received lifetime achievement awards from the UA alumni as well as the YWCA.

Another League member, Dr. Nelba Chavez, was the first administrator of the Substance Abuse and Mental Health Services Administration and the first Hispanic/Latina to head a public health agency in the 200 year history of the U.S. Dept. of Health and Human Services in the Clinton administration. She is an expert on mental health issues and headed local La Frontera for many years.

Laura Almquist, member of LWVGT, has served on the TUSD School Board, and is past Chair of the University Medical Center Board. She has actively served on numerous community boards and was 1980 Tucson Woman of the Year.

Teacher, businesswoman, and philanthropist Dorothy Finley taught school and served as a school principal before becoming President and CEO of Finley Distributing Company. The daycare center at Davis-Monthan is named in her honor. She has served on more than 50 non-profit boards in the community.

Estela Jacome came to our community as a girl from Argentina. During WW 2, she was one of a group of Tucson women who knitted sweaters and other things to support the English. She was a founder of the St. Mary's Hospital Auxiliary and accompanied her husband Alex on several diplomatic tours to Latin America.

Dr. Sally Drachman has both a Masters and Doctorate from the U of A. An advocate for Tucson, she has served as a director of development for many non-profit organizations. She has worked to advance educational research and funding.

Selma Paul Marks was the only female law school graduate in 1956 at the U of A. She spent 20 years as a Deputy County Attorney. In 2004 she received the UA College of Law Lifetime Achievement Award. She established the Marks Memorial Lectures at the U of A.

Esther Don Tang has been a dynamic community leader and business woman. In 1999 she was chosen by the White House to introduce President Bill Clinton to Tucson. The Secret Service surprised the diminutive Esther with her own step stool so she could be "eye to eye" with the President.

Edith "Edie" Auslander most recently served as Vice President and Senior Associate to the UA President. She also had a long career in newspaper work, including teaching journalism at the UA. She has won many honors as a Hispanic journalist as well as being named Tucson's Woman of the Year in 1986. She holds an honorary Doctor of Laws from the UA.

Doña Joana Damos graduated from the UA College of Law in 1953. She was the first woman appointed United States Attorney in Arizona. She is a historic preservationist and helped found and open the Pima Mental Health Center and La Frontera Clinic.

Patricia "Patty" Arida was one of the first registered nurses in the U.S. Air Force. While living in Washington, D.C. Patty assisted new Embassy wives arriving in the Capitol. After moving to Tucson, Patty helped establish the second Casa de los Niños home for older children and is a founding board member of the UA Sarver Heart Center. She also served on the El Rio Health Center Board.

For most of her life Genevieve Whalen has been serving our community. When she was just six years old, she danced the Mexican Hat Dance at Armory Park to raise money for the Veterans Hospital. She has worked with the Boy Scouts and served as a housemother for troubled youth. She was a dental assistant at the St. Elizabeth of Hungary Clinic and recruited volunteers for the clinic's outpatient clinic. She has been a Spanish language interpreter at UMC.

Martha Elias attended the UA and has served on many UA committees-including the UA Hispanic Alumni Awards Committee. She served on the City's Civil Service Commission. She has been a member of the Health Systems Rate Review Committee as well as the Pima County Judicial Performance Review Committee. She is a member of the TMC Foundation and past member of the Arizona State Health Coordinating Council.

## LWVAZ INDEPENDENT VOTER PROJECT

The "Indy" Project, sponsored by the LWVAZ, took place this past fall. Committed League volunteers scanned voter manuals and voter registration forms to find out how rules related to party affiliation impacted on independent voters. On current registration forms, for example, there is a place to check your party preference as a Democrat or Republican. However, if you are a member of other qualified political parties - those that have fielded candidates on the ballot in previous elections - or if you are an independent voter, your only choice is to check "other." Candidates running as "independent" are not included in current rules that allow ballots to rotate the names of candidates to keep from giving preference to the same candidate in the first position. To not be included in the rotation assigns a permanent lesser position to an independent candidate.

The study also raised (and answered) a sincere question. When asked why the League should be concerned for those who don't want to be in the Republican or Democratic parties, since they place themselves outside of parties, indicating their preference for not improving them, the answer was (paraphrased) "If the League won't speak for the concerns of one-third of the State's voters, who will?"

The Indy Project promises to have significance in a number of future areas of study and concern. For example, as local Leagues across the state worked on the Governor Succession consensus question, the discussion often centered on the role of independent candidates for public office at all levels. Clearly, the League is, by working on the Indy Project, better positioned to help in the quest for better rules related to independent voters.

## CAN YOU REGISTER A FEW VOTERS? ARIZONA NEEDS MORE "REGISTERED AND INFORMED" VOTERS!

Fact: 69% of eligible Arizonans are registered. 31% are not. In 2008, Arizona ranked 43<sup>rd</sup> in the US in turnout for the Presidential election.

The LWVGT Board is asking that each League member register five voters this winter/spring as our participation with the Justice Sandra Day O'Connor House Centennial Voter Engagement Project to increase voters in Arizona. In December 2011, the LWVGT Board voted to support this effort.

The O'Connor Project is asking Arizona non-profits to join this effort of registering voters. At your book club, church, exercise class, synagogue, homeowner's meeting, etc., you can take Registration forms and register voters.

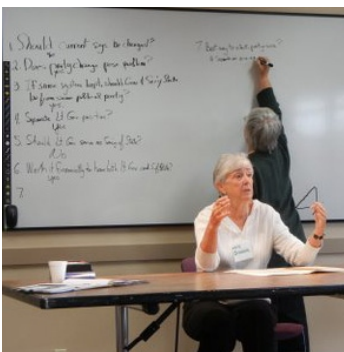
**Re-registration is needed if a person (1) moves, (2) changes his/her name or (3) changes Political Party.**

## ARIZONA'S EXECUTIVE BRANCH CONSENSUS MEETING

Thanks to all the League members that drove up to the Oro Valley Public Library for the November meeting.

The consensus meeting was led by Lois Brechner, LWVAZ Chair of this state study, who drove down from Surprise, AZ, to give the background on the study. Sue Ward and Gini McGirr assisted with the consensus questions.

The material was formulated and adopted at the Greater Tucson December board meeting and sent to Lois Brechner whose state committee came up with the position which was adopted at the January meeting of the LWVAZ Board.

## LEGISLATIVE UPDATE

The second session of the 50<sup>th</sup> AZ Legislature opened January 9<sup>th</sup> with 159 bills already in the hopper and more to come. The House has 40 Republicans and 20 Democrats. The Senate has 21 Republicans and 9 Democrats.

Bills on Education include providing state aid to private and parochial schools; eliminating requirements for teacher certification; encouraging smaller districts to consolidate, altering requirements for helping students learn English.

Sen. Melvin wants public support for transportation, storage and reprocessing of nuclear waste with the money paid by the government to go to the public schools. Health and safety would be an issue here.

Guns: To allow students and professors to carry guns onto college campuses; easing rules for guns in public buildings.

Government Issues: Revamping the Independent Redistricting Commission; ask voters to ban public funding of campaigns (Clean Elections); limiting gifts and trips that lawmakers can take; making it harder for voters to put initiatives on the ballot; removing the restriction on legislators immediately becoming lobbyists. Rep. Seel plans to bring back the "birther" bill. Sen. Gallardo is thinking of bill to repeal SB1070.

Other Issues: Registration: members of AZ Libertarian and Green parties are asking a federal judge to stop the state from using a new voter-registration form. The new form provides three choices: Republican, Democrat and small box for other. They feel this is unconstitutional as these parties have met the same legal requirements for state recognition.

American Elect: The political wild card for the Internet age is Americans Elect which has qualified for the ballot in 13 states and collected signatures in the 17 others that allow signature-gathering the year before the election. Any registered voter who signs up online will be a delegate and will choose a presidential ticket through successive rounds of Internet voting culminating in the choice of a candidate in June. The vice presidential nominee on this unity ticket must come from a DIFFERENT political party. They do not routinely disclose donors.

Open Primary aka Top Two: Group gathering signatures for ballot initiative which will change and reform the election process by implementing an open primary system where the top two vote getters, regardless of political party, will advance to a run-off election. The LWVAZ Board discussed this at the January board meeting and a representative of the group will be asked to speak at the March board meeting. Fruit Basket Upset: Sen. Steve Pierce replaces Sen. Russell Pearce as Senate President. Pearce lost the election to Jerry Lewis for his senate seat. Sen. Kyrsten Sinema and Rep. Kirk Adams have resigned to run for Congress. David Lujan appointed to replace Sinema. Possibility of Rep. Andy Tobin and Sen. Ron Gould also running. Sen. Scott Bundgaard resigned during an Ethics committee inquiry into his conduct. Rep. Jack Harper is quitting at the end of session and thinking of running for SOS. He has bill for increases in salary for state officials governor up to \$160,000.

Independent Redistricting Commission: The maps are being sent to the Dept. of Justice for their pre-clearance. The new maps have moved some incumbents who had been political allies into the same district. Some candidates are moving to different districts and some will be running against their own party candidate in the primary. There is a bill to let candidates get signatures from their old districts also which will probably be the first one on the governor's desk.

ALIS: Now that the Legislature is in session, I will be monitoring bills that the LWV has a position in support or in opposition. These will be up on the LWVAZ page on the AZ Legislature website as fast as I can get a synopsis of the bills. Go to the website: [www.azleg.gov](http://www.azleg.gov), in the middle of the page, click on ALIS Tracking; Click on Track; User ID is LWVAZ; password is Lila. Click on Personal Progress on the top middle of the page; page comes up with the five lists of bills that we are tracking: Education, Clean Elections/Judicial; Election Reform, Natural Resources and Social Policy. Click on any one of the bills; click on Print Progress Report to read them. This does not print them, just shows the overview of them.

# NEWS FROM STATE AND NATIONAL

**December 10, 1869, Wyoming was the first territory to give women the right to vote.**

**Election Year 2012 Resolutions/Hopes:** 1. Ensure all eligible voters are registered to vote and can exercise their right to vote without having to overcome unnecessary and restrictive hurdles. 2. Educate the electorate on the candidates and issues on their ballots and help them find their polling place. 3. Encourage informative and productive debates between candidates so voters can learn about their elected representatives through more than just sound bites. 4. Fight to make sure voters decide the outcome of elections, not special interest money. 5. Promise for clean air for children and their families, and change the discussion to the important issues facing Americans in 2012.

**League Endorses H.R. 2572, Clean up Government Act of 2011:** The League and coalition partners sent a letter to House Judiciary Chair Lamar Smith endorsing this Act which restores tools for federal prosecutors fighting public corruption.

**Save Presidential Public Financing & the Election Assistance Commission:** The LWV and other organizations oppose H.R.3463, that would repeal the presidential public financing system and terminate the Election Assistance Commission.

**Elections: LWV Fights Voter Suppression Laws:** As voter suppression laws sweep the nation, the League is fighting back. The LWV of Kansas is working in coalition to help educate and register voters before new, stricter laws go into effect. The LWV of South Carolina steps up the pressure urging the US Dept. of Justice to deny pre-clearance of the state's voter ID law. THEY WON. The LWV of Ohio succeeded in getting a measure on the ballot to overturn a newly enacted law that would decrease the number of early voting hours. The LWV of Florida has taken its message to national TV. LWVFL President McNabb rebuffed a state legislator, who supported the state's new restrictions on citizen registration drives.

**"Patriocracy": Just Released Movie about the US Political Divide and Some Possible Solutions:** A new documentary offers a non-partisan examination of the Washington dysfunction and hyper partisanship undermining America's ability to tackle its most serious problems. Since the movie offers a backdrop to the election year ahead, the LWVUS partnered with the Leagues of New Hampshire and South Carolina to show the film just prior to the presidential primaries in their states. President MacNamara led panel discussions following each screening. All Leagues are encouraged to sponsor their own public showing of this film, which will serve both educational and visibility objectives. **LWVAZ:** The Board adopted a new state position on the Executive Branch of Government. See page 2.

The Board adopted a priority statement for the LWVUS 2012 priorities: The LWVAZ urges the LWVUS to make the fight against the Citizens United ruling one of the 2012 priorities.

The LWVAZ filed an amicus brief on the lawsuit on the Independent Redistricting Commission in November.

LWVAZ is planning on sponsoring a High School Seniors Essay Contest and will raise funds for \$500 first prize. This should reach out to new voters as HS seniors and their parents and teachers.

The Board discussed the "Open Government" initiative and will ask a representative to speak at the March board meeting to find out more about this plan. There is background material from other state Leagues.

The Board sponsored the "Indy" Project when members scanned the voter manuals and voter registration forms to find out how rules related to party affiliation impacted independent voters. (See article elsewhere in this Voter)

The Board voted to join with the Justice Sandra Day O'Connor House Centennial Voter Engagement Project to increase voters in Arizona. All local Leagues will be asked to work on this project.
